




Figure 1. Forward Current vs. Forward Voltage




Figure 2. Dynamic Forward Resistance vs. Forward Current






Figure 3. Admissible Power Dissipation vs. Ambient Temperature




Figure 5. Leakage Current vs. Junction Temperature




Figure 4. Relative Capacitance vs. Reverse Voltage





Figure 6. Admissible Repetitive Peak Forward Current vs. Pulse Duration
